5. The Sexual Harassment of Women at Work Place (Prevention, Prohibition and Redressal Act) Act, 2013
6. The Criminal Law Amendment Act, 2013.
7. The Maternity Benefit Act, 1961.
8. The Medical Termination of Pregnancy Act, 1971 (34 of 1971).
9. The Immoral Traffic (Prevention) Act, 1956.
10. The Pre-Conception and Pre-Natal Diagnostic Techniques (Prohibition of Sex Selection) Act, 1994.
11. The Minimum Wages Act, 1948.
12. The Minimum Wages Act, 1948.
13. SC and ST (Prevention of Atrocities) Amendment Act, 2015.
14. The Scheduled Tribes and other Traditional Forest dwellers (Recognition of Forest Rights) Act, 2008.
